The meeting started with the recitation of Holy Quran.

Rahat Lateef, on the premise that requisite quorum was available to conduct the business of the meeting, initiated the proceedings with the permission of the Chairman by introducing the panel and announced the agenda of EOGM as follows:

1. To confirm the Minutes of the Annual General Meeting of the Company held on October 28, 2021.
2. To elect Ten (10) directors, being the number of directors fixed by the Board, for a period of three years, commencing from January 14, 2022 in accordance with the provisions of Section 159 of the Companies Act, 2017 and Articles of Association of the Company.
3. To transact any other business as may be placed before the meeting with the permission of the Chair.

Peter Riepenhausen welcomed the shareholders to the meeting, described his journey with the Company over the years and then informed them about his retirement from the Company. He also praised the efforts and contribution of the outgoing management and the founder and ex-CEO of the Company Zia Chishti. He then opened the floor for discussion on the agenda items which was as follows:

One of the shareholders, namely Abdul Wahab Ghaffar Kodvavi CDC A/c. Muhammad Afzal CDC A/c No. 007039023051, being one of the shareholders whose signature was allegedly forged was present in person at the meeting and he confirmed that such proxy had not been issued by him. Abdul Wahab Ghaffar Kodvavi requested the Company Secretary to bring the matter on record and minute it accordingly. Asad Nasir further replied that he was not involved in any manner, nor had anything to do with obtaining these proxies as these were submitted to the Company directly. Rahat Lateef apprised the members that the Company also received written complaints from such shareholders the previous day. Given that it was not possible to verify the signatures on the Proxies or the letters at that point in time, the matter was discussed with the members and it was finally decided and agreed to that while this matter was serious and should be placed on record, however, due to the nominal number of shares involved in respect of such proxies, the elections would proceed as planned.
